**Guest Speakers**

**President Gilbert:**

- Congratulates Men's Soccer Team on National Championship.
- Enrollment edges up towards Fall 2021 but could be down slightly from last fall.
- No longer requiring ACT or SAT scores, except for scholarship consideration.
- Summer camps going on this summer.
- Provost leaving for Lamar University.
- College of Business Dean Mukherjee is Interim Provost.
- Chad Pennington now member of the Board of Governors.
- Cole Pennington will join football team in 2022.
- Covid testing will continue this fall.
- 75% of staff COVID vaccinated.
- Student vaccination rate under 50%.
- Incentives for students to get vaccinated.
- Stringent COVID testing for unvaccinated students will be in place this fall.
- Jeff O'Malley appointed Interim Athletic Director
- Mike Hamrick stepping down to focus on baseball stadium funding.
- Search under way for new President
- Opportunities for alumni to have input in President search
- Space study under way to move programs to Corbly Hall after new business building opening.
- Aviation program ribbon cutting at Yeager Airport on August 10<sup>th</sup>.
- Aviation Maintenance program to begin in January 2022.
- Jean Edward Smith memorial scheduled for August 31<sup>st</sup>. He is the author of *Bush*, a biography of the 43rd president; *Eisenhower in War and Peace*; *FDR*, winner of the 2008 Francis Parkman Prize of the Society of American Historians; *Grant*, a 2002 Pulitzer Prize finalist; and *John Marshall: Definer of a Nation*.

**Dr. Ron Area – MU Foundation:**

- Marshall rises campaign exceeds goal of \$150M—close to \$160M. Celebrations will happen this fall. Electronic screens on campus will promote the success.
- 40,000 gifts over last 5 years. Most are from donors that have given in the past.
- Level of participation of alumni is important in the national college rankings.

- 1/3 are new donors
- 500 new scholarships will be funded, a 44% increase from current numbers.
- Over \$44M in scholarship endowments.
- Foundation funding creates new programs, e.g., cyber security & aviation.
- Marshall should attract great candidates for the new President.
- Success in the advancement area will attract the leader that we need.
- Foundation will be helping with the new College of Business building financing. The foundation has an arrangement with United Bank to borrow the money before the Brad Smith donations flow into the Foundation so that new building can be completed by 2023.

**Coach Grassie:**

- Intensity is the goal of the soccer team. Intensity in the classroom and on the soccer field.
- Last summer, didn't do team meetings, just sent them home.
- Started a new JV team with 15 players in Fall 2020.
- Spring started out with bad weather and a COVID outbreak.
- As the 2021 season progressed, team missed the community support.
- CUSA Championship vs. Charlotte - our fans were buying majority of 600 tickets allotted.
- Being in NC was incredible.
- Incredible team. The whole effort felt magical.
- He knew we were going to beat Indiana.
- Lifting the trophy was a special moment.
- On paper, we are should be a better team this year.
- Thinking how we can regenerate Huntington with new baseball stadium and other attractions on the former ACF property.
- Would like to increase seating capacity of the soccer stadium.

- Doctor of Business Administration Program starts this fall – 15-16 in initial cohort.
- 3 new Master degree programs.
- Aviation Management degree major to compliment aviation program
- Accreditation review next year – College of Business enrollment is up; online program growing; growth in graduate programs as well.
