Campus & Foundation Updates

Dr. Avi Mukherjee, Provost & Sr VP for Academic Affairs

- Marshall for All, Marshall Forever
- Increasing on-line instruction
- Higher Education Market Pricing. Believe not all programs should be the same price. Different programs should have different prices due to demand. Focusing on 60 miles around Marshall.
- Process of decentralization

Dr. Marcie Simms, VP for Intercultural & Student Affairs

- Used to have a VP for Intercultural and one for Student Affairs, but now on VP (one division)
 - Counseling, Student Organization, East Hall (Shanta), LGBTQ, International office, student advocacy, etc.
 - Upcoming – 4 programs with events on 10/28, communication plan reviewing website and create an app, HerdLink is used to put in events – has an assessment component that hasn't been used but they will begin to use it. This shows how many people attended an event. Asked faculty to make it an extra credit in class for students to attend an event.
- Walter Tatum – 70 people involved in student government, 56 senators. Secretary was recently appointed (Zach Kincaid) but he couldn't be here today, so Walter is making this presentation. Discussion on changes needed to “active” alumni terms

Voting schedule

- Used to have election and then officers would not take office until 6 months after the election.
- Section 3.4. Elections. Each year, no more than ten (10) Directors shall be included on a ballot and elected from the active membership of the Corporation. The Nomination Committee will develop a ballot of a minimum of ten (10) and a maximum of twenty (20) nominees to run for the Directors' positions, with consideration to the balance provision contained in this paragraph of this article. Ballots listing the new Director nominees will be sent to all Active Members of the Corporation at least thirty (30) days prior to ~~the annual meeting any monthly Board meeting~~. The Active Members must return the ballots to the Alumni Office ~~at least ten (10) days prior to the annual meeting within fifteen (15) days of the circulation of ballots~~. The nominees who receive the highest number of votes will be elected as Directors of the Corporation; however, a balance shall be maintained so that at least five (5) Directors elected each term reside outside Cabell, Wayne, Mason, Putnam, Kanawha, Lincoln, Logan and Mingo Counties in West Virginia, Boyd County in Kentucky and Lawrence County in Ohio. No more than two (2) full time employees of Marshall University can

serve as elected Directors at one time. The Secretary of the Corporation will notify all nominees of the results of the election. The remaining nominees will be listed in order of votes received and designated as alternate Directors for three (3) years.
