  - \$50k Endowment Fund Goal by 2026
  - Balance available from past earnings in fund 350900 (the expendable fund) \$807.61, but Dave is going to ask Scott about this. Dave and Jimmy thought the amount would be 1,000 – 1,100.
  - The endowment principle is \$30,296.89 at 8/31/2023 with accumulated appreciation through 6/30/2023 of \$2,120.56 for a market value north of \$32,000.
  - Endowment activity this fiscal year (7/1/2023-8/31/2023):

Beginning balance, corpus	\$29,361.51
Additions	935.38
Withdrawals (Spending/fees)	<u>0.00</u>
Ending balance, corpus	<u>\$30,296.89</u>
